This course will survey both chronologically and topically the history of North Carolina from its beginning in the 17th century up to the present time. We will seek to understand the events of this history in terms of individual decisions and the forces that shaped them, which have created the North Carolina of today.

1. Required text: *North Carolina History through Four Centuries* by William S. Powell.
2. Attendance: You are expected to attend class regularly. You may have 4 unexcused absences. If you exceed that amount, you will be dropped from the class. To receive an excused absence, you must contact me within 48 hours after your absence, by phone or e-mail. Most acceptable excuse: you are too ill to be in class.
3. Papers and student presentations: Each of you will be actively involved in your own instruction, by researching and writing two short papers from a list of topics I will provide. You will also each take a turn in teaching the class, by presenting the results of your research in a short oral presentation. (If making a talk is not your thing, you may write longer papers instead.)
4. Grades: Each paper will be 20% of your final grade; each oral presentation will be 10%. The mid-term and the exam will each be 20%. The final will be a take-home essay. You will be given study guides for each.
5. The class will be a mixture of lecture and discussion. Your thoughts and observations will be valued!
6. The following class schedule gives the time frame for completing the reading, which will track our coverage in class.
